SECTION 4: FIRST-AID MEASURES

Inhalation	Remove the casualty to fresh air and keep at rest in a position comfortable for breathing. If breathing is difficult, give oxygen. If breathing has stopped, give artificial respiration. Obtain medical attention.
Skin Contact	Remove contaminated clothing and shoes immediately. Wash the affected area with plenty of soap and water for at least 15 minutes. Obtain medical attention if irritation develops or persists.

Suitable Extinguishing Media	Water spray, dry chemical powder, carbon dioxide (CO ₂) or alcohol-resistant foam.
