SECTION 4: FIRST-AID MEASURES

SECTION 5: FIRE-FIGHTING MEASURES

Suitable Extinguishing Media	Water spray, dry chemical powder, carbon dioxide (CO ₂) or alcohol-resistant foam.
Unsuitable Extinguishing Media	High-pressure water jet.
Specific Hazards	Thermal decomposition may generate irritating and toxic gases. Containers may rupture when heated.

Conditions for Storage	Store in the original, tightly closed container in a cool, dry, well-ventilated place away from direct sunlight and heat. Keep away from incompatible materials listed in Section 10. Store in a bunded area where liquids are held.
