SECTION 4: FIRST-AID MEASURES

Suitable Extinguishing Media	Water spray, dry chemical powder, carbon dioxide (CO ₂) or alcohol-resistant foam.
Unsuitable Extinguishing Media	High-pressure water jet.
Specific Hazards	Thermal decomposition may generate irritating and toxic gases. Containers may rupture when heated.
